

## Minutes January 14, 2014 SJMA Meeting

The meeting was called to order by Lenka, filling in for Kathy, at 12:01 p.m. In attendance were Lenka, Valerie, Dan, John Lang, Kathy, Mark, Jessica Short (guest), Rachel, Dhez and Leslie.

There was not a Director of Membership Report but Lenka reported as Director of Communication that she will send out an email about the hockey event. Flyers have gone out.

Rachel will provide a wrap up of the first year of the Retiree Connect pilot project at the next meeting.

The discussion on Bylaws will be continued to the next meeting.

There was discussion about using PayPal for retiree dues and event fees. It will be promoted as an option on the website once the HTML code is added to the SJMA website.

There was discussion as to whether to raise retiree dues since there has not been an increase in several years while event-related costs continue to increase. There are 36-38 retiree members for 2014. The board considered a proposal to increase rates by \$1 per month for an annual retiree membership rate of \$36 per year. This increase still maintains a considerable discount for retiree members in comparison to the rate for a current manager membership. Mark made a motion to accept the proposal. Dan seconded. The board approved the retiree membership increase by a vote of 8-0-1 with Lenka abstaining.

Lenka will follow up with Claudia about sending a letter to retirees to consider renewing their SJMA membership for 2015 as well as informing them about the new membership rate.
